# Veterans Coordinating Council John Selfridge, 218 Representative

It certainly has been an interesting, confusing and frustrating ride these past several months as events unfolded before VCC.

I must say that the newly elected officers of the VCC—Bob Handy as Chair and Ellery Price as Vice-Chair--have certainly changed the direction of the organization.

Earlier this year Marge Beavers, the former manager, was returned to her old job as part of an agreement to settle an employment lawsuit filed by her against the VCC for wrongful termination in June 2013. Beverly Ochoa was also rehired as assistant.

The chair of the VCC, Steve Penner, had to resign in January due to a conflict of interest in representing the VCC as its attorney before the Labor Board and also serving as Chair.

There were a number of confusing issues that followed: namely the motion proposed by Bob Handy (not yet the Chair) which called for the new sitting Chair, Michael Cook, to be censored and removed from his position. That motion was approved, then quickly rescinded when it was realized that there would be no authorized individual to represent the VCC at the Labor Board hearing! But at the next monthly meeting, Mr. Handy once again called for the resignation of Mr. Cook, only this time the motion was stated as "a request to resign, not a forced termination". Mr. Cook did step down when the motion passed, which lead to the election of Mr. Handy as Chair.

A motion was then introduced to request that the County Supervisors let the "old guard" run the building as they have done for the past sixteen years or so and for that "team" to remain in place for at least another year, well beyond the June 2014 deadline for the County General Service Department to take over management of the building.

I want to see the VMB remain for the use of Veterans for many years to come, but I'm not sure the VCC would be able to accomplish that goal without some necessary changes.

In my opinion, the only thing I can see that will attract

younger Iraq/Afghanistan Veterans to the VMB will be for the VCC to set a goal to include those Veterans on the council and for them to have a vote. This would require a change in the by-laws to recognize the fact that Congress had not chartered a Veterans organization since the late 90's. And it does not appear as though it will do so anytime soon, which is a shame considering that over 2.5 million men and women have served during the course of these two wars.

So the "old guard" of the VCC needs to get with the program and honor the service of these men and women and openly welcome the "new guard".

We must attract Veterans under the age of 40 if the VMB is to survive well into the future. Stated another way: if you were old enough to be drafted you were old enough to VOTE. We won that fight across this nation over fifty years ago, so why is this not the rule at our own Veterans building?

My worry is that the new Vets are not very eager to join the same groups that were not interested in us when we came home. This needs to change!

The next scheduled meeting of the VCC is Wednesday, April 30 at noon.

# Chapter 218 Scholarship Challenge

In January, the chapter committed to supporting two scholarships this year and to increase the amount of each to \$750. They will be awarded later this year in the names of Michael C. Dominquez and Stephen B. Neal, both Santa Barbara County residents who died in Vietnam.

The deadline for funding of both scholarships is May 1, 2014. As of this writing the chapter has raised nearly \$750! That means we are nearly half way to our goal of \$1,500 to fund these two scholarships... and you can help.

"The cost of college has risen sharply over the past five or six years," notes chapter member John Kerr, chair of the scholarship committee, "but even our rather small amounts have proved to be vital when combined with other monies from the Scholarship Foundation of Santa Barbara."

For the two local Vietnam Veterans who lost their lives incountry, it means that their names, their sacrifice and their legacy will continue to live on through these scholarships.

### VA Removes Annual Income Reporting Requirement

WASHINGTON –The Department of Veterans Affairs (VA) is eliminating the annual requirement for most Veterans enrolled in VA's health care system to report income information beginning in March 2014. Instead, VA will automatically match income information obtained from the Internal Revenue Service and Social Security Administration.

"This change will reduce the burden on Veterans, improve customer service and make it much easier for Veterans to keep their health care eligibility up-to-date", said Secretary of Veterans Affairs Eric K. Shinseki.

Some Veterans applying for enrollment for the first time are still required to submit income information. There is no change in VA's long-standing policy to provide no-cost care to indigent Veterans, Veterans with catastrophic medical conditions, Veterans with a disability rating of 50 percent or higher, or for conditions that are officially rated as "service-connected."

VA encourages Veterans to continue to use the health benefits renewal form to report changes in their personal information, such as address, phone numbers, dependents, next of kin, income and health insurance.
